How to be able to drive legally ?

The law requires all drivers to be insured under what is commonly called « civil liability ». This guarantees compensation for damage that could be caused to others by the driver of the car or its passengers in an accident. Of course you can add to this policy other guarantees to protect yourself and other passengers.

How to calculate premium ?

The cost of your car insurance in Spain depends on several factors :

- Your age
- Your years of driving
- Your car
- The use of your car
- Your place of living
- The guarantees wanted
- The number of prior sinister



Did you know ?

Having a driving lesson in Spain is interesting for financial and practical reasons. Indeed, delays to obtain it are shorter and from the beginning you are credited of 8 points out of 12.

A « bonus » of 3 points exists for drivers who do not make any mistake.

CAR INSURANCE FOR NEWCOMERS ?

Can we insure a foreign car in Spain ?

It is possible to insure any car with foreign license plates in Spain during three months, only when formalities to get Spanish plates are already engaged. For more information on this point, see the last page.

Exception : if your car has a license plate from British or Northern Ireland you can insure it for one year without any formalities.

In order to insure your car you would need :

- A NIE (Numero de identidad Espanol)
- A spanish mailing address
- A spanish number account
- « no claim discount » from your past insurance company

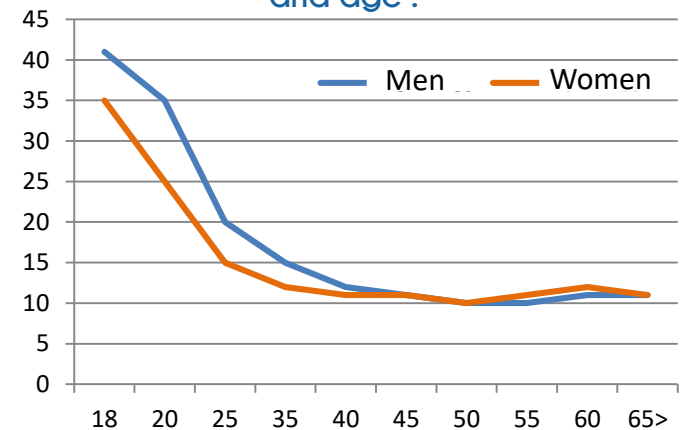
Which formalities to insure a car ?

INOV INSURANCE'S PIECES OF ADVICE TO GET SPANISH LICENSE PLATES

WHICH ELEMENTS ?

Get Spanish license plates relatively easily, you only need four elements :

HOME



Certificate of compliance : Delivered on simple request by car company maker or any dealership of your brand in Spain.



Vehicle test and « certificado de características del vehículo »
Available in the car repair shop of your cars' brand.



Ask for license plate change : Go to the « Jeratura provincial de tráfico » of your region with : Your resident card or your passport, the original and a copy of your car registration document, the original and a copy of your car invoice.



Pay taxes to :

- Your city council : municipal tax on vehicles
- The treasury : you will be exonerated
- The Autonomous community : wealth transfer taxes
